4. FIRST AID MEASURES		
Inhalation:	If not breathing, give artificial respiration. If breathing is difficult, oxygen should be administered by qualified personnel. Move to fresh air. If symptoms persist, seek medical advice. Asthmatic-type symptoms may develop and may be immediate or delayed up to several hours. Extreme asthmatic reactions can be life threatening. Get medical attention.	
Skin contact:	Wipe off with paper towel or cloth. Immediately flush skin with plenty of water (using soap, if available). Remove contaminated clothing and shoes. Wash clothing before reuse. For severe exposures, get under safety shower after removing clothing, then get medical attention. For lesser exposure, seek medical attention if irritation develops or persists after area is washed. Thoroughly clean shoes before reuse.	
Eye contact:	Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Seek medical attention immediately.

5. FIRE FIGHTING MEASURES

Extinguishing media:	Water spray (fog), foam, dry chemical or carbon dioxide.
Special firefighting procedures:	Wear self-contained breathing apparatus and full protective clothing, such as turn-out gear. Water should be used to cool closed containers to prevent pressure build-up and possible autoignition or explosion when exposed to extreme heat. Explosive rupture is possible.
Unusual fire or explosion hazards:	Sealed containers at elevated temperatures or contaminated with water may rupture explosively. At higher temperatures isocyanate may be released. Water or fog may cause frothing which can be violent especially if sprayed into containers of hot or burning liquid. Do not allow run-off from fire fighting to enter drains or water courses.
Hazardous combustion products:	Oxides of carbon, oxides of nitrogen, irritating organic vapors. Hydrogen cyanide. Isocyanates.

6. ACCIDENTAL RELEASE MEASURES

Use personal protection recommended in Section 8, isolate the hazard area and deny entry to unnecessary and unprotected personnel.

Environmental precautions:

Do not allow product to enter sewer or waterways.

Clean-up methods:

Remove all sources of ignition. Evacuate and ventilate spill area; dike spill to prevent entry into water system; wear full protective equipment during cleanup. Refer to Section 8 "Exposure Controls / Personal Protection" prior to clean up. If temporary control of isocyanate vapor is required, a blanket of protein foam (available at most fire departments) may be placed over spill. Large quantities may be pumped into closed, but not sealed containers for disposal. For minor spills, absorb isocyanates with sawdust or other absorbent, shovel into suitable unsealed containers, transport to well ventilated area (outside) and treat with neutralizing solution: mixture of 80% water and 20% non-ionic surfactant Tergitol TMN-10; or 90% water, 3-8% concentrated ammonia and 2% detergent. Add about ten parts of neutralizer per part of isocyanate, with mixing. Allow to stand uncovered for 48 hours to let carbon dioxide escape. Decontaminate floor with decontamination solution letting stand for at least 15 minutes.

7. HANDLING AND STORAGE

Prevent contact with eyes, skin and clothing. Do not breathe vapor and mist. Wash thoroughly after handling. Use only with adequate ventilation. Protect from moisture. Keep container closed. Employee education and training in the safe use and handling of this compound are required under the OSHA Hazard Communication Standard. Refer to Section 8.

For safe storage, store between 15 °C (59°F) and 30 °C (86°F) Keep container tightly closed and in a cool, well-ventilated place away from incompatible materials. Store away from heat, sparks, flames, or other sources of ignition. Do not let moisture contaminate this material. Product reacts with water to release carbon dioxide, which could build up pressure in closed containers and lead to bursting. Do not reseal if moisture contamination is suspected. Do not reseal if contamination is suspected. If container is exposed to high heat (204.4 °C (400 °F)), it can be pressurized and possibly rupture.

Engineering controls:	Use local exhaust ventilation if the potential for airborne exposure exists. Standard reference sources regarding industrial ventilation (i.e., ACGIH Industrial Ventilation) should be consulted for guidance about adequate ventilation. Air monitoring: Monitoring of airborne isocyanates in the breathing zone of individuals should become part of the overall employee exposure characterization program. Isocyanate exposure levels must be monitored. Monitoring techniques have been developed by NIOSH and OSHA. Medical Surveillance: Medical supervision of all employees who handle or come in contact with isocyanates is recommended. Persons with asthmatic-type conditions, chronic bronchitis, other chronic respiratory diseases or recurrent skin eczema or sensitization should be excluded from working with isocyanates. Once a person is diagnosed as sensitized to an isocyanate, no further exposure can be permitted.
Respiratory protection:	A positive pressure, supplied-air respirator or a self-contained breathing apparatus is recommended when: airborne concentrations of isocyanate are known to exceed 0.005 ppm; operations are performed in a confined space or area with limited ventilation; material is heated or sprayed. Observe OSHA regulations for respirator use (29 CFR 1910.134).
Eye/face protection:	Safety glasses with sideshields or chemical safety goggles should be worn if there is a risk of splashing. Full face protection should be used if the potential for splashing or spraying of product exists. Safety showers and eye wash stations should be available. Vapor resistant goggles should be worn when contact lenses are in use.

Storage:

Use chemical resistant, impermeable clothing including gloves and either an apron or body suit to prevent skin contact. Permeation resistant gloves (butyl rubber, nitrile rubber, polyvinyl alcohol). However, please note that polyvinyl alcohol degrades in water. Cover as much of the exposed skin area as possible with appropriate clothing. If skin creams are used, keep the area covered by the cream to a minimum. Safety showers and eye wash stations should be available. Educate and train employees in safe use of product.

Potential Health Effects/Symptoms

Inhalation:	May cause respiratory tract irritation. May cause allergic respiratory reaction. Persons with preexisting, nonspecific bronchial hyper-reactivity can respond to concentrations below the TLV with similar symptoms as well as lead to bronchitis, bronchial spasm and pulmonary edema (fluid in lungs). These symptoms, which can include chest tightness, wheezing, cough, shortness of breath or asthma attack, could be immediate or delayed (up to several hours after exposure). Overexposure to isocyanates has been reported to cause lung damage.
Skin contact:	Causes skin irritation. May cause allergic skin reaction. Isocyanates react with skin protein and moisture and can cause irritation which may include the following symptoms: reddening, swelling, rash, scaling or blistering.
Eye contact:	Causes serious eye irritation. Liquid, aerosols or vapor are irritating and can cause tearing, reddening and swelling. Damage however is usually reversible. See Section 4 for First Aid measures.
