4. FIRST AID MEASURES

Description of necessary measures

Inhalation:	Remove from exposure area to fresh air. Treat symptomatically and supportively.
Skin contact:	Rinse affected area with large amounts of water until no evidence of product remains. Get medical attention if irritation persists.
Eye contact:	Immediately rinse eyes with plenty of water for at least 15 minutes while holding eyelids open. Get medical attention if pain or irritation develops.
Ingestion:	Dilution by rinsing the mouth and giving water or milk to drink is generally recommended. Contact physician or local poison control center.

Most important symptoms and effects, both acute and delayed

After eye contact: May cause moderate to severe irritation, with possibility of corneal injury if not removed promptly. After skin contact: Repeated or prolonged excessive exposure may cause irritation with redness, blistering, skin damage or dermatitis. After Ingestion: Ingestion may cause pain, burning, swelling and redness in the mouth and throat. Nausea and vomiting may occur. Harmful if swallowed. After inhalation: Dust may cause mucous membrane irritation with coughing and shortness of breath.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures
